Position Purpose

Key Responsibilities

- Oversee daily operations of feedyard and spelling facility to promote optimal growth for cattle with a focus on minimising the stress and health problems of cattle.
- Involved in all aspects of animal handling in the feedlot including health check, and other associated feedlot stock movements.
- Operating farm machinery including loader, tractor, Feed Wagon, Augers.
- Record management of feed allocation using BMS (Bunk Management System)
- Diagnosis of animal health symptoms and administration and recording of animal details and health treatments and notification to the Livestock Administrator.
- Ensure feedlot is clean and well maintained.
- Maintenance of fences in feedlot.
- May be required to assist in other areas of the station activities as directed by the manager.
- Ensure compliance with Company Policies and Procedures within the scope of the position including ensuring approval for all orders before placing requests.
